Terms and Conditions

1. One pitch of up to 10m width. Vendors will need to provide their own gazebo-type covers if required.
2. All sales must be carried out on the pitch. Selling on the body of the site or approaching ticketholders off the pitch is not permissible
3. Stallholders are requested to limit use of single use plastics wherever possible and use more environmentally friendly resources. They are also required to provide a receptacle for any waste produced by their stalls and to recycle as much waste as possible.
4. Each stallholder will be issued with 2 tickets. Any additional tickets required can be purchased in advance. Please contact Amanda Watkins to discuss.
5. Each stall holder can have one vehicle on the field; this vehicle must be onsite by 18.00 if trading on the Friday or 12.30 on the Saturday. Additional vehicles are permitted onto the site to help setup and offload between 9.30 and 12.00 and must then be parked in the off-site car park. If a second vehicle remains on site after 12.30 when the vehicle gate is closed, then a second stall will be charged for at an additional £50.
6. No vehicle movements are permitted after 18.00 on the Friday until 1 hour after the end of the last act and between 12.30 and 1 hour after the end of the last act on the Saturday, unless agreed with an Official Steward who will lead the vehicle.
7. Food vendors must be registered with their Local Authority and provide this information to HNCA at the time of booking
8. Public Liability insurance must be held and proof of this provided at the time of booking.
9. Overnight camping is available free of charge
10. To secure a pitch full payment is required by 30th April.
11. Electrical hook ups can be provided for an additional charge to cover the cost of hire and fuel. This will vary depending on use required and will be in the region of £25 - £50.

We will be observing all Government Coronavirus regulations and guidance that may be in place at the time of M@C. By signing the vendor agreement, all stallholders are agreeing to abide by these rules.
